Pursuant to the provisions of Regulation 30 (read with Part A of Schedule III) of SEBI (Listing Obligations and Disclosure Requirements), Regulations 2015, we are pleased to inform that, yesterday i.e. on December 23, 2020, the Company received permission to open its Parks from the Government of Maharashtra vide Unlock Order No: DMU/2020/CR.92/DisM-1, dated December 21, 2020. Pursuant to the said order, the Theme Park will be opened with Limited Operations with effect from December 25, 2020. The Water Park will however remain non-operational until further Intimation.

Company will continue to deliver services in line with the vision of Best in class entertainment for delightful memories in clean, safe and happy environment. The Theme park will be strictly operated as per the SOPs, Guidelines, Safety Measures directed by Government of Maharashtra. We all are committed to ensuring safety of our guests and employees.
